### Harmonized Sales Tax (HST)

In spite of much opposition, *HST* is happening...and this is a key detail.

**When annual slip fees are both invoiced and paid for on or before April 30, 2010 they will not be subject to the additional 8% tax. If the fees are not paid in full by that date the portion of the fee that applies after July 1, 2010 will be subject to the *HST*.**

***Boaters: Pay attention to this one. It could save you considerable money!!***

### Pleasure Craft Operator Card

After a 10-year phase in period, all Canadian boaters are now required to have their **Pleasure Craft Operator Card**, commonly referred to as a boating license. Effective now, anyone operating a powered watercraft recreationally in Canada must be able to show their card or risk the penalty of expensive fines.

**This law applies to all ages.** Some think a young person must be 16 years of age to get certified...or if you're 65 or older you are grandfathered. Neither is true. There is no minimum age to get certified and no age exemption. Others believe you don't need the card if your motor is less than 10 horsepower but in fact it's needed to operate any size of powered watercraft...even an electric motor on a canoe for example.

The 36 question, multiple-choice exam requires a 75% mark to receive a passing grade. And boaters can print a temporary card as soon as they pass online and their permanent card is mailed to their home in a few weeks. The card is good-for-life and never needs to be renewed.

"Taking the test online is convenient and the study material is free", says **Boater Exam** spokesperson Robert Dupel. **Boater Exam** also has a large national database of Canadian boaters and would be a good place to contact for anyone looking to replace their lost card. Chances are they have their record on file said Dupel.
